### 4. First-aid measures

#### Description of first aid measures

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

#### Appropriate engineering controls

Provide adequate ventilation. It is the user's responsibility to satisfy himself as to the suitability of such information for his own particular use.
